Rodgers, MD Achievement Award by the National Association of Community Health Centers. This prestigious annual award, established in 1977, honors the legacy of Samuel U. ### Denver Health receives three-year grant from CDC

The Centers for Disease Control and Prevention recently created a grant called Communities and Hospitals Advancing Maternity Practices (CHAMPS) to assist hospitals in underserved areas improve lactation care and breastfeeding rates over three years. Denver Health was selected as one of 100 hospitals across the country, and the only one in Colorado, to participate. This is an opportunity for Denver Health by providing resources for staff training and education regarding lactation, and the program closely aligns with our mission to improve equity in peripartum care. 
### Labor Day closures and service update

Protect our crew, prevent the flu!

Important employee deadlines for 2024:

- Friday, Oct. 11 Deadline to submit medical or religious exemption form
- Friday, Oct. 25 Deadline to submit offsite documentation request (non-Denver Health clinic)
- **Tuesday, Nov. 5** Deadline for all employees to comply with Influenza Vaccinations Policy

This year's vaccination clinics will be offered on five days in three locations, with additional opportunities for weekend and overnight staff coming soon. Registration is no longer required.

### Schedule set for 2025 benefits open enrollment

Open enrollment is the one time per year employees can change their benefit elections without a qualifying life event. The 2025 benefits open enrollment period will be **Monday, Oct. 21** through **Monday, Nov. 4**.

There are changes to our benefit plans for next year – below is a summary:

- Two new medical plans with pharmacy plan design and rate changes
- Enrollment is required, otherwise an employee will default to a plan based on current coverage
- Fitness Center membership rate change, which includes the addition of an evening yoga session and monthly group fitness center introduction classes
- Identity Theft Protection through Norton LifeLock voluntary benefit offering
- Increased medical flexible spending account annual maximum and special instructions for those that fall into the highly compensated definition for dependent care flexible spending
- Preparing for a third-party Dependent Audit coming during the first quarter of 2025


Employees have the following options available during the open enrollment period:

- Enroll over the phone by calling the Benefit Concierge, 303-602-6947, option 2.
- Schedule an appointment at https://www.employeeconnects.com/denveralth/ with a Benefit rep.
- Self-enroll using Workday.
- Visit the Employee Resource Center in Pavilion B during business hours to get assistance in the computer lab.

Detailed information about open enrollment along with plan design, premiums and enrollment instructions will be sent via mailed postcard, digital postcards, future 411 communications, benefits website on the Pulse, and targeted email communications throughout open enrollment to help guide employees through the process.

### Temporary closure and operational changes scheduled for helipad repairs

Employees should be aware of an important update regarding our primary helipad, Helipad A, located over the Emergency Department. Due to age and wear, Helipad A will undergo extensive repairs and restoration starting at **6 a.m. Monday, Sept. 9**, with an expected completion date of **Friday, Nov. 1**.



What to Expect:

- Surface restoration and coating: enhancing the surface for safety and durability
- Redesign and installation: new helipad markings and control signage
- Stair replacement: northeast-facing stairs will be removed and replaced
- Fencing and lighting: new chain link fencing and lighting installation

Operational changes:

- Helipad A closure: Helipad A will be out of service for the duration of the project.
  Alternate landing site: All flight traffic will be redirected to Helipad B. located on the
- Alternate landing site: All flight traffic will be redirected to Helipad B, located on the south side of Pavilion A over the lab.
- Crane operations: On Sept. 9 and Nov. 1, from 6 a.m.- 4 p.m., a crane will be in use. During these times, ambulance traffic should use the pediatric ambulance entrance when possible. In urgent cases, the adult ambulance bay can be accessed via the driveway.

Please share this information with your teams to ensure everyone is prepared for the helipad closure and potential impacts on ambulance routes. Our Denver Health Paramedic Division Dispatch will keep flight and ambulance crews informed via EMResource. We will provide updates as the project progresses.


